## **APPLICATION/INSTRUCTIONS FOR USE**

By foam cannon By low-pressure spraying:

- Concentration of 3% to 8% for bodyworks.
- Concentration of 5% to 8% for tarpaulins, engines, chassis.

Action time: 5 to 10 minutes Optimal temperature: 40°C. At the end of the operation, rinse with high-pressure water (100 bar). Test the corrosion resistance of certain paints (fragile, old, brushed, polished).
